


Percentage Veterans Served by Provider [Q28e]


Percentage Chronically Homeless Served by Provider [Q28i]

Percentage with Co-Occurring Disorder Served by Provider [Q28f]











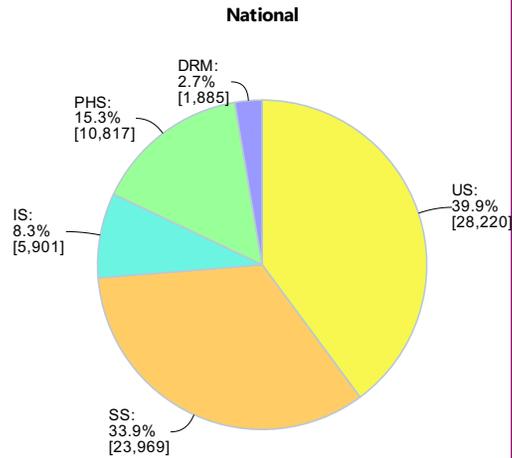











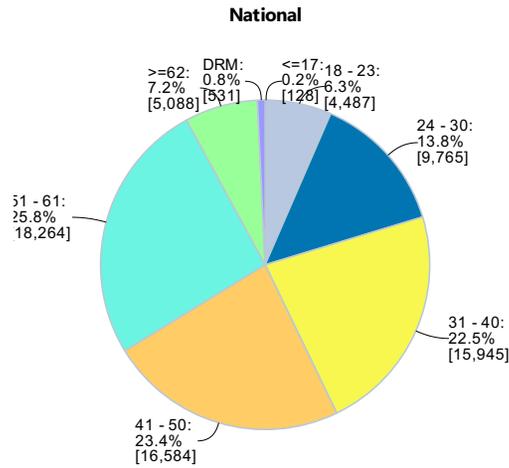
Percentage of Females Served by Provider [Q28a]









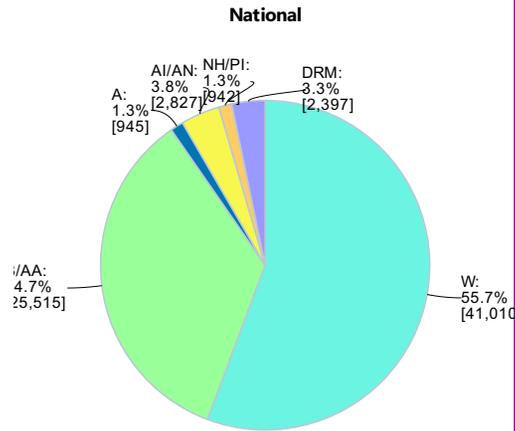
Percentage of Hispanic/Latino Served by Provider [Q28d]











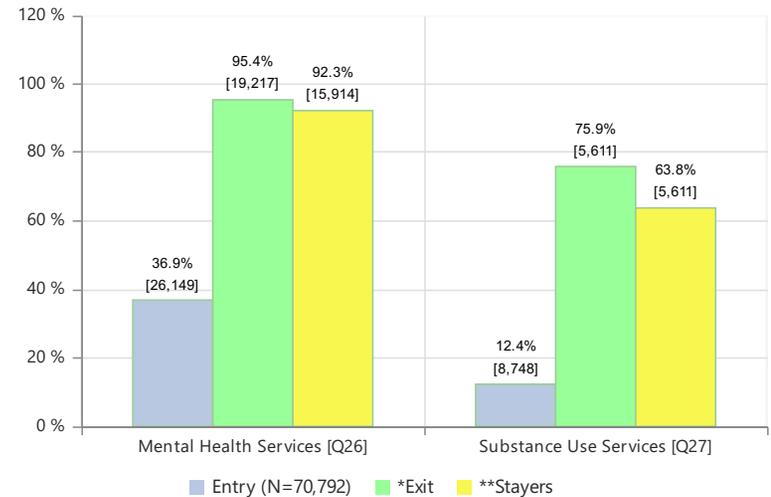



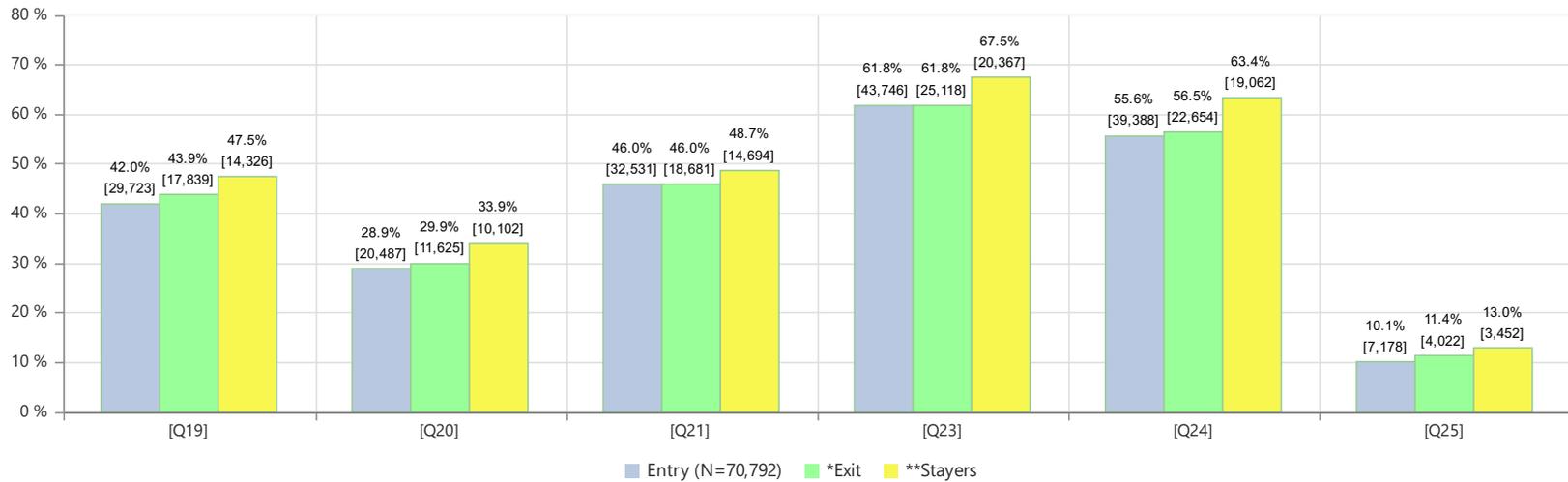
